

EARN IT

You may be eligible for the Earned Income Tax Credit (EITC) based on your earnings, number of qualifying children, and filing status. You may also be eligible for the Child Tax Credit (CTC), Elderly Credit or Disability Credit.

KEEP IT

Don't pay expensive tax preparation or refund/loan fees. Prosperity Campaign trained counselors or IRS certified tax preparers will help you process and **e-file** your taxes for **FREE**.

SAVE IT

Open a bank account, build savings or pay bills and improve your credit. Ask a volunteer at the tax site for information on ways to put your money to work for you.

If your family earned less than \$38,348 in 2006, you may qualify for up to \$4,356 cash back in Earned Income Tax Credit (EITC) when you file your tax return. At more than 60 free tax preparation locations throughout Hillsborough and Pinellas counties, qualified volunteers and staff will make sure you claim every tax credit to which you are entitled.
